ALLEGATION(S)

- 1) I was contacted yesterday on May 30, 2017 by Tom Beedy, someone I know personally, indicating he received a phone call from a Massachusetts phone number stating his name as Fabio. Tom believed it to be my stalker, Javier who claimed he was my boyfriend and wanted to know details about a trip that I was scheduled to take to NH several weeks ago. The caller describes in detail the fact that I canceled the trip and the caller wanted to know if I ~~was~~ was using the airline credit to take a future flight. The caller claims that I left the caller's house on 5/29/17 crying over our alleged and continued romantic relationship. The only person (male) who knew about my trip to NH was Javier Manjarres.
- 2) Javier has entered my building and on my floor (secured) numerous times without my knowledge or invitation. I made numerous attempts in telling Javier to Never come to my house without my knowledge. Javier has a criminal history, owning guns, prior arrest records, domestic violence and stalking claims. I made it very clear to him that I was fearful of him. Javier has showed up to public places where he should have no idea I was there.
- 3) Javier has broken into my cell phone and has taken snapshot of my contacts (ex Tom Beedy) and private messages between

- 4) Javier saw me and my ex-boyfriend, Phil one evening at Yolo Restaurant. As we were leaving, Javier approached Phil, said, "Are you Phil Verde?" "I know everything about you." "I'm Javier." "I've been fucking Wendy the past four weeks". This was done in a public restaurant and made me absolutely fearful of Javier. How does Javier know Phil?
- 5) Javier send numerous extremely ^{long} text messages at all hours/day that are extremely sweet natured at first then ~~the~~ tone becomes very accusatory and aggressive by the end. His erratic/disturbing behavior has me fearful for my safety.

I simply want Javier to never step foot in my apartment and to stop contacting/speaking to ex-boyfriends or current relationships and to stop getting into my phone.

- 6) I have blocked Javier from my contacts (ex phone, whatsapp, and facebook)

Javier has a history of stalking and attempted murder charges. I have witnessed his stalking behaviors on my own.


